CRAFT VENDOR RULES AND REGULATIONS 42nd. ANNUAL SULLIVAN COUNTY FALL FESTIVAL

- **1. ELIGIBILITY**: All exhibitors must have a PA Sales Tax Number if owning a business. Two applicants may share a booth; however, a separate application must be submitted by each person for each craft.
- 2. CRAFTS/VARIETY VENDOR: Juried crafts and variety vendors are accepted for this event. If juried, demonstration of your craft/product is encouraged.
- **3. ART AND PHOTOGRAPHY** prints must be from the original work of the artist of record. Final interpretation of commercial status will be made by the Festival Committee.
- 4. ACCEPTANCE/REJECTION: Applications will be accepted right up until the week of the event if space is available, we do our best to place you in the same location as the previous year. Contact the Chamber for other arrangements. The Chamber reserves the right to reject any applications for any reasons for the good and success of the event.
- 5. JURIED CRAFTS: We encourage juried crafts with a demonstration making the craft if possible
- 6. PARKING: After set-up, vendors <u>MUST</u> move their vehicles to the flat public parking area. The only exception to this is for handicapped persons. In this case, please send us a photocopy of the handicapped person's parking permit/tag.

Parking passes provided (up to **2 people per Vendor**) for display on your dashboard will be available at the information office in the 4H Building at set up. If these are lost, you will be charged admittance at the gate and later reimbursed if you come to the information booth at the 4H building.

7. **PETS:** On the grounds must be well behaved and must be keep on a leash at all times and the owner must clean up after pet.

8. CAMPING: Available only for food vendors requiring refrigeration. For a list of campgrounds, inns, motels, and B&B's nearby go to <u>www.sullivancounytpachamber.com</u>

9. BOOTH AREAS: Please man your booth area from 9:00 a.m. until 5:00 p.m. both days. NOTE: No children under 12 years old will be allowed in the booth area, either inside or outside booths.

10. TABLES AND CHAIRS (All vendors) and TENT (Outside Vendors): Must be provided by vendor.

11. NOT PERMITTED: Use of alcoholic beverages and/or drugs on fairgrounds.

12. SECURITY: Overnight security will be provided.
